



## Website and Cookies Privacy Notice

This privacy notice has been written to inform you about how we process your personal data when you visit our website, and in particular our use of cookies and web analytics.

### Who are we?

North Yorkshire Rural Schools Federation comprises: Foston CE, Langton, Stillington Community, and Terrington CE Primary Schools. Each school in the Federation is a data controller as defined by the UK GDPR. This means that we determine the purposes for which your personal data is processed and how it is processed. We will only collect and use your personal data in ways that are compliant with data protection legislation.

We have appointed Veritau Ltd as our Data Protection Officer (DPO). The role of the DPO is to monitor our compliance with the UK GDPR and the Data Protection Act 2018 and advise on data protection issues. ### Web analytics

Web analytics is the collection and analysis of the data generated when people visit and use a website. This helps the website owner know such things as the number of visitors to various parts of the website, the time they spend on the website and if they

return to the website. Various tools are used to produce web analytics, such as Google Analytics, which uses a set of cookies to collect data.

## **What are cookies?**

A cookie is a small file of text that may be saved on the memory or storage of your electronic device (computer, phone, or tablet, etc.) when you visit a website. Cookies are used to improve the way the website works and can be used to remember the information you've provided so that you don't have to re-enter it on subsequent pages.

Two types of cookies are typically used:

**Session cookies** – these are temporary and are removed when you close your browser or leave a website. These are used to remember visitors as they move from page to page on a website and are typically used to store your basket when using online shopping.

**Persistent cookies** – these remain on your device for much longer, even after you close the browser or restart the device. They remain until you remove them or they expire, which can be up to 12 months. They are typically used to store information such as your name, language preferences, or login information.

## **What do we use cookies for?**

We use cookies so that:

- We can distinguish you from other users of our website and provide a good experience.
- We can remember the information you've provided us with while on our website, so you don't have to keep re-entering the information whenever you visit a new page.
- We can look at how you use our website so that we can improve it for other users.

We do not use cookies to:

- Monitor your usage of other websites (privacy intrusive cookies).
- Collect any personal information about you (without your express permission).
- Collect any sensitive information.
- Pass data to any advertising networks.
- Pass personal data to third parties.

## Consent for cookies

When you first visit our website using a new browser, we will provide you with a cookies permission banner, seeking your consent for the use of certain cookies.

Not all cookies require consent. Those which are needed for the operation of the website, known as 'strictly necessary' cookies, do not require consent. Without these cookies, the website cannot work as designed.

We also use other cookies which do not require consent, such as those that enable us to collect information for statistical purposes about how you have used our website, or cookies that allow you to choose the website's appearance and functions.

Other types of cookies do require consent. These include:

- Advertising or marketing cookies, which are used to target advertising on a website.

You can change your cookie preferences at any time through our cookie banner, but please be aware that opting out of cookies may affect your user experience on our website.

<b>Google Analytics</b> _utma _utmb _utmc _utmz	Used to track your movement around the website, we use this information to see what information is popular and then tweak the website to ensure people access the most relevant information easily. <b>Vimeo</b>	This may be set if we have embedded a Vimeo video on a page. This is a 3 <sup>rd</sup> party cookie set by them and is governed by their privacy policy, which can be found at <a href="https://vimeo.com/cookie_policy">https://vimeo.com/cookie_policy</a>
<b>Facebook</b>	Only set if any official facebook widgets are included in the site. This is a 3 <sup>rd</sup> party cookie set by them and is governed by their privacy policy, which can be found at <a href="https://www.facebook.com/policy.php">https://www.facebook.com/policy.php</a>
<b>Twitter</b>	Only set if any official twitter widgets are included in the site. This is a 3 <sup>rd</sup> party cookie set by them and is governed by their privacy policy, which can be found at <a href="https://twitter.com/privacy">https://twitter.com/privacy</a>
